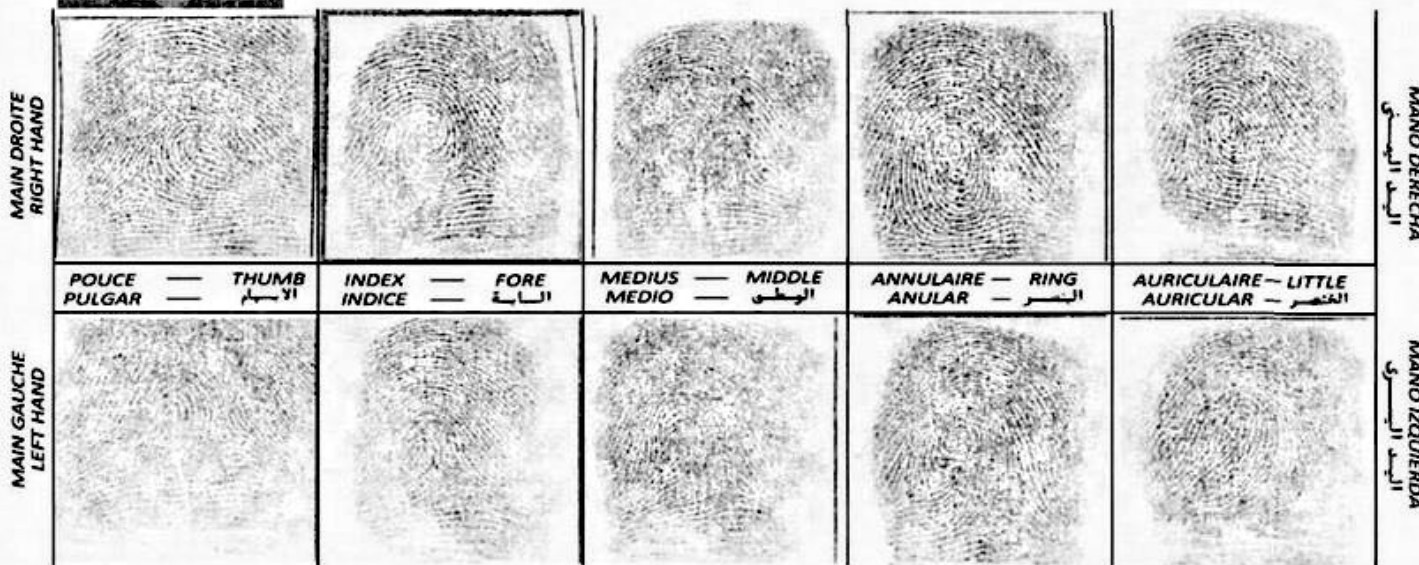

Summary of facts of the case

From at least June 2017 to April 2018, Seuxis Paucis HERNANDEZ-SOLARTE conspired with others to produce and distribute approximately 10,000 kilograms of cocaine in Colombia, to be imported into the United States and elsewhere. HERNANDEZ-SOLARTE and his co-conspirators were members and associates of the Revolutionary Armed Forces of Colombia (FARC). HERNANDEZ-SOLARTE and his co-conspirators participated in a series of meetings with other individuals during which they discussed providing thousands of kilograms of cocaine that would be imported into the U.S. HERNANDEZ-SOLARTE and his co-conspirators represented that they had access to laboratories to supply the cocaine, and that they had access to U.S. registered airplanes to transport the cocaine within and through Colombia. HERNANDEZ-SOLARTE and his co-conspirators provided kilograms of cocaine to others as evidence of their access to ton quantities of cocaine.

Additional facts of the case:

Beginning in June 2017, three of HERNANDEZ-SOLARTE's co-conspirators participated in a series of meetings during which they discussed providing thousands of kilograms of cocaine to other individuals that would be imported into the U.S., and ultimately agreed to provide other individuals with a sample of five kilograms of cocaine. On 01 November 2017, one of the co-conspirators delivered the five kilogram sample of cocaine to an individual at a hotel lobby in Bogota, Colombia. The next day, HERNANDEZ-SOLARTE and one of his co-conspirators met with the buyers of the cocaine at HERNANDEZ-SOLARTE's residence. During the meeting, HERNANDEZ-SOLARTE acknowledged that they provided cocaine to others, and directed the other co-conspirator to coordinate a larger transaction of cocaine. After the meeting, HERNANDEZ-SOLARTE and his co-conspirators continued to negotiate the planned sale of a larger quantity of cocaine. On 08 February 2018, HERNANDEZ-SOLARTE and one of his co-conspirators met again with the buyers of the cocaine at HERNANDEZ-SOLARTE's residence. During the meeting, HERNANDEZ-SOLARTE and his co-conspirator agreed to provide 10,000 kilograms of cocaine and the buyers agreed to provide \$15 million USD toward the purchase of that cocaine, which the buyers would deliver to one of the co-conspirator's associates in Miami, Florida. HERNANDEZ-SOLARTE's co-conspirator stated that the first 7,000 kilograms of cocaine would be delivered within a month, and the remaining 3,000 kilograms of cocaine would be delivered in the following 30 days. HERNANDEZ-SOLARTE then directed his co-conspirator to work out the details of the cocaine transfer with the buyers. Following the meeting, HERNANDEZ-SOLARTE and his co-conspirators continued to discuss the potential shipment of a large amount of cocaine to the buyers, including by using U.S. registered aircrafts to transport the drugs.

Under U.S. law, a person charged with manufacturing or distributing illegal narcotics intending, knowing, or having reasonable cause to believe that such narcotics will be unlawfully imported into the United States or into waters within a distance of 12 miles of the coast of the United States, shall be tried in the U.S. District Court at the point of entry where such person enters the United States, which in this case, would be the U.S District Court for the Southern District of New York.
